**DESCRIPTION:**

Germicide liquid algaecide to control pool water algae or to disinfect non-porous surfaces such as showers and indoor pool decks against most harmful bacteria and germs. Acting also as an organic odors killer.

**DIRECTION FOR POOL ALGAECIDE:**

1. Initial dosage for pool water having no visible algae is 120 mL of GERMICIDE per 10,000 L of pool water.
2. Weekly maintenance dosage is 60 mL of GERMICIDE per 10,000 L of pool water.
3. For pool water having visible algae, superchlorinate following label instructions of superchlorination agent used and wait at least 24 hours before adding weekly maintenance dosage.
4. For visible algae, when superchlorination is not employed, add 300 mL of GERMICIDE per 10,000 L of pool water. Do not apply when swimmers are in the immediate vicinity (a 15-minute restricted entry interval is recommended.)

**DIRECTIONS TO DISINFECT NON-POROUS HARD SURFACES, SHOWERS AND INDOOR POOL DECKS:**

**Against Trichophyton mentagrophytes (causative agent of athlete's foot disease) and to destroy bacteria.**

1. Use prepared solution of 5 mL/L of water. Do not mix with soap or anionic detergent.
2. Apply on pre-cleaned surfaces. Use a mop, sponge or cloth to disinfect.
3. Allow surface to remain wet for 10 minutes, then remove excess liquid.
4. Prepare a fresh solution for each use.

**PRECAUTIONS:**

KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. Do not mix with any other chemical. Wear rubber gloves when handling this concentrate.

**FIRST AID:**

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If swallowed, Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. IF inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-

mouth, if possible. Call a poison control centre or doctor for further treatment advice. Call a poison control centre or doctor for treatment advice. Call a physician or poison control centre IMMEDIATELY. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**DISPOSAL:**

Do not reuse empty container. Rinse container thoroughly before disposal. Wrap and dispose in household garbage. For information on the disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill and for clean-up of spills.

Treat symptomatically.
