DIRECTIONS FOR USE: 1. Stand serves as holder for the coil: pull the center piece to upright position. 2. Loosen outer rings until ends move freely. 3. Grasp each comma-shaped portion in the center between thumb and forefinger of each hand. 4. Separate the two comma-shaped coils by gently pressing them in opposite directions 5 mm (1/4") apart. 5. Hold one comma-shaped end and shake lightly or gently pry apart to separate coils. 6. Insert tip of metal stand into slot in comma shaped end of coil. 7. Light outer end of coil until glowing. 8. Place coils 2-3 meters (6-10') apart around area to be protected.

Use in outdoor areas such as backyards, patio, decks, etc. which are sheltered from effects of wind and more easily protected by coils. For best results do not use in wind. In light winds place coils up wind where possible to make use of the associated drift. If shorter periods of use are desired break coil into appropriate length and place in notched cut-out of holder. Coil will burn for approximately 6 hours.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. DO NOT USE IN RESTAURANTS, COVER EXPOSED FOODS TO AVOID CONTAMINATION. DO NOT TOUCH LIT END. DO NOT PLACE IN DIRECT CONTACT WITH FLAMMABLE SURFACES. AVOID PROLONGED INHALATION.

FIRST AID: IF IN EYES - Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF ON SKIN OR CLOTHING - Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

IF SWALLOWED - Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.
