DIRECTIONS FOR USE:

SECTION 1

Crop: WHEAT, BARLEY, OATS

Treatment Stage:

For ground or aerial application. Treat when crop is in the 3 to 6 leaf stage.

Do not apply more than once per year.

GO TO SECTION 3

SECTION 2

Crop: FLAX (Excluding low-linolenic acid varieties)

Treatment Stage:

For ground application only. Treat when flax is 5 to 10 cm high.

Do not apply more than once per year.

GO TO SECTION 3

SECTION 3

WEEDS CONTROLLED AND RATES OF APPLICATION

Susceptible Weeds:

Burdock, Cocklebur, Mustards (except Dog Mustard), Ragweed, Flixweed*, Kochia, Lamb's-quarters, Russian Pigweed, Shepherd's Purse, Stinkweed.

*Flixweed susceptible only at seedling stage. Use rates for harder to kill weeds to kill fall germinated flixweed in the spring.

Rate to Use On Susceptible Weeds: 1.6 L/ha

Harder to Kill Weeds: Hempnettle (suppression only), Canada Thistle (top growth suppression only).

Treatment Stage: Treat when Hempnettle is in 2-4 leaf stage

Rate to Use on harder to kill weeds: 2 L/ha

NOTE: For use on Flax, apply in at least 100 L per hectare of water.

SECTION 4

TANK-MIXES WITH WEEDAWAY MCPA K400:

Use tank-mixes only when they are registered and recommended. Read and follow all label directions on both products used in a tank-mix. Ensure all components of tank-mix are registered for aerial application.

1. TANK-MIX: WEEDAWAY MCPA K400 + Banvel 480

Crop: WHEAT, BARLEY (Not underseeded to legumes)

Treatment Stage: Apply at the 2-5 leaf stage of the crop.

Susceptible Weeds: Weeds susceptible to WEEDAWAY MCPA K400 plus Wild Buckwheat,

Smartweed, Corn Spurry, Hempnettle, Canada Thistle, Russian Thistle.

Rates to Use:

WEEDAWAY MCPA K400 1 L/ha +

+ Banvel 480 Wheat: 230-290 mL/ha

Barley: 230ml/ha

Do not apply more than once per year.

2. TANK -MIX: WEEDAWAY MCPA K400 + PARDNER® HERBICIDE

Crop: SPRING AND WINTER WHEAT, BARLEY and OATS (Not Underseeded).

Treatment Stage: Apply at the 2 leaf to early flag leaf of crop. Winter wheat at 2-4 leaf in fall or from when growth begins to early flag leaf in spring.

Susceptible Weeds:

Up to 4 leaf stage weeds.

Red Root Pigweed, Flixweed, Shepherd's Purse, Volunteer Sunflower, Ball Mustard, Green Smartweed, Pale Smartweed, Lady's Thumb, Bluebur, American Nightshade, Nightflowering Catchfly, Cocklebur, Scentless Chamomile(1), Volunteer Rapeseed/Canola(2), Cow Cockle(2), Hempnettle(2), Triazine Resistant Pigweed(2), Canada Thistle(3), Perennial Sowthistle(3), Kochia(4), Russian Thistle(4), Velvet Leaf(5).

- 1. Spring annuals only.
- 2. Use high rate of WEEDAWAY MCPA K400 in tank-mix, not controlled beyond 4 leaf.

- 3. Top growth control only.
- 4. Spray before weeds are 5 cm high.
- 5. Spray before weeds are 8 cm high.

Up to 8 leaf stage weeds.

Wild Mustard, Wormseed Mustard, Wild Buckwheat Tartary Buckwheat, Common Buckwheat, Common Groundsel, Lamb's-quarters, Stinkweed, Common Ragweed.

NOTE: Check Pardner label for further details or rates and timings for specific weeds noted. **CAUTION:** Wear chemically-resistant nitrile gloves when working with this tank-mix.

Rates to Use: WEEDAWAY MCPA K400+ 690 mL/ha* to 1.375

L/ha +

PARDNER 1 L/ha

*Do not exceed 690 mL/ha rate of WEEDAWAY MCPA

K400 on winter wheat using this tank-mix.

Do not apply more than once per year.

MIXING AND APPLICATION INSTRUCTIONS:

- 1. Fill Tank 1/2 full with water. Start agitation.
- 2. Add MCPA K400.
- 3. Where PARDNER or Banvel is mixed, add them after MCPA K400
- 4. Complete filling of spray tank with water.
- 5. Use 100-240 litres of water per hectare for application by ground equipment unless otherwise specified.
- 6. Do not exceed 275 kPa pressure for ground application.

Field Sprayer Application: DO NOT apply during periods of dead calm. Avoid application of this product when winds are gusty. DO NOT apply with spray droplets smaller than the American Society of Agricultural Engineers (ASAE) coarse classification. Boom height must be 60 cm or less above the crop or ground.

Aerial Application: DO NOT apply during periods of dead calm. Avoid application of this product when winds are gusty. DO NOT apply when wind speed is greater than 16 km/h at flying height at the site of application. DO NOT apply with spray droplets smaller than the American Society of Agricultural Engineers (ASAE) coarse classification. To reduce drift caused by turbulent wingtip vortices, the nozzle distribution along the spray boom length MUST NOT exceed 65% of the wing- or rotorspan.

Buffer Zones to Protect Sensitive Habitat

Spot treatment DOES NOT require a buffer zone.

The buffer zones specified in the table below are required between the point of direct application and the closest downwind edge of sensitive terrestrial habitats (such as grasslands, forested areas, shelter belts, woodlots, hedgerows, riparian areas and shrublands), sensitive freshwater habitats (such as lakes, rivers, sloughs, ponds, prairie potholes, creeks, marshes, streams, reservoirs and wetlands), and estuarine/marine habitats.

When a tank mixture is used, consult the labels of the tank-mix partners and observe the largest (most restrictive) buffer zone of the products involved in the tank mixture.

^{*}For field sprayer application, buffer zones can be reduced with the use of drift reducing spray shields. When using a spray boom fitted with a full shield (shroud, curtain) that extends to the crop canopy, the labelled buffer zone can be reduced by 70%. When using a spray boom where individual nozzles are fitted with cone-shaped shields that are no more than 30 cm above the crop canopy, the labelled buffer zone can be reduced by 30%.

Use Precautions for Aerial Application (to cereal crops)

- 1. Aerial applicators must wear long pants and a long-sleeved shirt.
- 2. Mixers/loaders must wear long pants, a long-sleeved shirt and chemical-resistant gloves during mixing, loading, clean-up and repair activities.
- 3. Aircraft must use a closed cab.
- 4. Mixer/loader and applicator must be different individuals.
- 5. Use special care in aerial application where damage from drift can be greater.

- 9. Coarse sprays are less likely to drift. Use only nozzles or nozzle configuration which minimize the production of fine spray drops. Do not angle nozzles forward into the airstream and do not increase spray volume by increasing nozzle pressure. When spraying, avoid combinations of pressures and nozzle type that will result in fine particles (mist) which are more likely to drift. A spray thickening agent or drift retardant may be used with this product to aid in reducing spray drift

RESISTANCE MANAGEMENT RECOMMENDATIONS:

For resistance management, WEEDAWAY MCPA K400 is a Group 4 herbicide. Any weed population may contain or develop plants naturally resistant to WEEDAWAY MCPA K400 and other Group 4 herbicides. The resistant biotypes may dominate the weed population if these herbicides are used repeatedly in the same field. Other resistance mechanisms that are not linked to site of action, but specific for individual chemicals, such as enhanced metabolism, may also exist. Appropriate resistance-management strategies should be followed.

To delay herbicide resistance: Where possible, rotate the use of WEEDAWAY MCPA K400 or other Group 4 herbicides with different herbicide groups that control the same weeds in a field. Use tank mixtures with herbicides from a different group when such use is permitted. Herbicide use should be based on an IPM program that includes scouting, historical information related to herbicide use and crop rotation, and considers tillage (or other mechanical), cultural, biological and other chemical control practices. Monitor treated weed populations for resistance development. Prevent movement of resistant weed seeds to other fields by cleaning harvesting and tillage equipment and planting clean seed.
