FIRST AID:

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

IF SWALLOWED: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

DO NOT apply when swimmers are in the immediate vicinity (a 15-minute restricted-entry interval is recommended).

INITIAL DOSE: Add 20 ml BAQUA CHECK 50 per 10,000 liters of pool water.

MAINTENANCE DOSE: Add 10 ml BAQUA CHECK 50 per 10,000 liters of pool water. Initial dose is used when filling the pool.

Maintenance dose should be added weekly. If high temperatures prevail or pool has unusually heavy use, add maintenance dose more frequently.

Maintenance dose should be added after a heavy or prolonged rainfall.

For pool water having visible algae, superchlorinate following label instructions of superchlorination product employed and wait at least 24 hours before adding weekly maintenance dosage.

For visible algae, when superchlorination is not employed, add 40 ml of BAQUA CHECK 50 per 10,000 liters of pool water.
