DIRECTIONS FOR USE:

1. For best results, drain and clean the system before adding fresh metalworking fluid.
2. Add ~~Duraecool 6451~~ to the use dilution of the metalworking fluid to obtain a final concentration of 0.15% ~~Duraecool 6451~~ (150 mL per 100L of diluted metalworking fluid).
3. Add ~~Duraecool 6451~~ to the use dilution of the makeup metalworking fluid to obtain a final concentration of 0.15% ~~Duraecool 6451~~.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. DANGER: CORROSIVE TO EYES. Wear eye

FIRST AID:
