TOXICOLOGICAL INFORMATION: Chlorpyrifos is an organophosphate that is a cholinesterase inhibitor. Typical symptoms of overexposure to cholinesterase inhibitors include headache, nausea, dizziness, sweating, salivation, runny nose and eyes. This may progress to muscle twitching, weakness, tremors, incoordination, vomiting, abdominal cramps and diarrhea in more serious poisonings. A life-threatening poisoning is signified by loss of consciousness, incontinence, convulsions and respiratory depression with a secondary cardiovascular component. Treat symptomatically. If exposed, plasma and red blood cell cholinesterase tests may indicate degree of exposure (baseline data are useful).

Atropine, only by injection, is the preferable antidote. Oximes, such as pralidoxime chloride, may be therapeutic if used early; however, use only in conjunction with atropine. In cases of severe acute poisoning, use antidotes immediately after establishing an open airway and respiration. With oral exposure, the decision of whether to induce vomiting or not should be made by an attending physician.
