## NOTICE TO USER

## FIRST AID

**IN CASE OF POISONING**, contact a physician or a poison control centre **IMMEDIATELY**. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**If inhaled**, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**If in eyes**, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

## TOXICOLOGICAL INFORMATION

No specific symptoms of poisoning are known for this product. If ingested, nausea, vomiting, diarrhoea and abdominal pain may occur. Treat symptomatically.

## PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

Harmful if inhaled. Avoid inhaling or breathing dust.

Avoid contact with eyes, skin and clothing. Wash with soap and water after handling, and before eating, drinking or smoking. Wash contaminated clothing before re-use. Do not wear contaminated shoes.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats (such as lakes, rivers, sloughs, ponds, prairie potholes, creeks, marshes, streams, reservoirs, ditches and wetlands, estuaries and marine habitats) by cleaning of equipment or disposal of wastes.
