DIRECTIONS FOR USE:

THOR Acticide BW20 Microbiocide Liquid is an effective in-can preservative in the following aqueous compositions. Application ranges of use concentrations based on the total weight of product are as follows.

Use	Amount of THOR Acticide BW20 Microbiocide Liquid based on total weight of product
Latex emulsions	0.03 - 0.075%
Aqueous based paints	0.03 - 0.25%
Aqueous mineral slurries	0.04 - 0.25%

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN.

FIRST AID:
