NOTICE TO USER: This pest control product is to be used only in accordance with the directions on the label. It is an offence under the Pest Control Products Act to use this product in a way that is inconsistent with the directions on the label.

FIRST AID:

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. **DO NOT** induce vomiting unless told to do so by a poison control centre or doctor. **DO NOT** give any liquid to the person. **DO NOT** give anything by mouth to an unconscious person.

DIRECTIONS FOR MIXING: Shake well. Add 50 mL of Safer's Trounce Lawn & Turf Insecticide to 1 litre of water. Mix thoroughly. Apply using any standard hand-held trigger sprayers, hand sprayers or backpack sprayers.

DIRECTIONS:

LAWN INSECTS: To kill chinch bugs, ants and earwigs in lawns and turf. Spray listed pests to wet when they first appear. Thorough coverage is essential to effectively kill these pests. To enhance effectiveness of this product, apply directly to the listed pests where possible. Complete contents of container (1L) will provide approximately 7-21 square metres of coverage, depending on the severity of the pest problem. In areas with high pest populations, apply contents of container (1L) evenly over 7 square metres. In areas with lower pest populations, coverage may be extended up to 21 square metres. **DO NOT** exceed 0.143 L of diluted spray per m². Treatment must only be repeated after 10 days if pest problem persists or reoccurs.

Use Limitations

- **DO NOT** apply to any body of water.
- **DO NOT** contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.
