**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. Supervise applications on children. DO NOT USE ON INFANTS UNDER 6 MONTHS OF AGE. In 6 month to 2 year olds, do not apply more than once a day. Not for daily use. Avoid application to hands. In 2 to 12 year olds, do not apply more than 3 times per day. Avoid contact with eyes and mouth, rayon, dnyel and acetate, plants, furniture finishes, plastics and painted surfaces. Keep away from open flame or spark.

**FIRST AID:** If irritation or other adverse effects develop wash with soap and water immediately. Seek medical attention if symptoms persist.

**If in eyes,** hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**If ingested,** call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do NOT induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If inhaled,** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**STORAGE:** Store this product away from food and feed.

**DISPOSAL:** Do not reuse empty container. Wrap and dispose of empty container with household garbage.
