DIRECTIONS FOR USE:

Use Preventol A8 Technical Fungicide to formulate wood preservatives registered under the *Pest Control Products Act*.

Detailed information on chemical and physical properties and other formulating recommendations for Preventol A8 Technical Fungicide are available upon request from LANXESS Corporation Obtain and read this information before undertaking the formulation of Preventol A8 Technical Fungicide in order to avoid formulation hazards and insure a satisfactory finished product.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Causes moderate eye irritation. Harmful if swallowed or inhaled. Avoid breathing dust. Avoid contact with eyes or clothing. Wash thoroughly with soap and warm water after handling and before eating, drinking or smoking. Wash contaminated clothing with soap and hot water before reuse.

FIRST AID:

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take the container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

No specific antidote is available. Treat symptomatically.

ENVIRONMENTAL HAZARDS:

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

STORAGE AND DISPOSAL: STORAGE: Store in a cool, dry place and in such a manner as to prevent cross contamination with other pesticides, fertilizers, food, seed and feed. Store in original container and out of the reach of children, preferably in a locked storage area.
