DIRECTIONS FOR USE:

SHAKE WELL BEFORE USING.

Wasp & Hornet Control*: Hold the can in an upright position. While approaching nest from an upwind position, begin spraying nest and flying pests from a distance of 2 to 4 meters. Spray nest and nest opening thoroughly.

Yellow Jacket & Bee Control*: Spray in a sweeping motion to knock down flying insects around the opening of the nest. Move forward and spray directly into nest opening. For large nests, more than one can may be necessary.

***Note:** If possible, application to nests should be made in early morning or at dusk when insects are at rest.

Ant Control: Spray the entire mound and perimeter. For large colonies, break up mound with stick and spray all active ants.

Spider, Cockroach, Earwig & Silverfish Control {Crawling Insects}: Spray pests directly. Thoroughly spray infested areas and along outside surfaces of screens, doors, windows, foundations, or other places where insects may enter or congregate.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. DO NOT USE ON ANIMALS OR HUMANS.

Causes skin irritation. DO NOT get on skin. Avoid contact with eyes and clothing. Avoid inhaling spray. Wear a long sleeved shirt and chemical resistant gloves when applying, or when handling utility equipment contaminated with spray residue. Do not leave wet contaminated clothing in contact with skin for extended periods. Wash well after handling and before eating, drinking, smoking and using the toilet. Wash contaminated clothing with soap and hot water before re-use. For use in enclosed spaces, vacate for at least 15 minutes after each treatment and aerate before re-entering. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. **If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
