## DIRECTIONS FOR USE

To be used only in the manufacture of pest control products which are registered under the *PEST CONTROL PRODUCTS ACT*.

### FIRST AID:

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

IF SWALLOWED, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF INHALED, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

IF IN EYES, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF ON SKIN OR CLOTHING, Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

### PRECAUTIONS: KEEP OUT OF REACH OF UNAUTHORIZED PERSONNEL

Harmful if swallowed or inhaled. Harmful if absorbed through skin or eyes. May cause eye irritation. Do not breathe the vapor and avoid getting on skin or in eyes. Wear protective clothing and rubber gloves. Remove and wash contaminated clothing before reuse. Anyone handling this product should wash themselves thoroughly with soap and water before eating, drinking or smoking.
