Also repels black flies, biting midges, deer flies, stable flies, ticks and chiggers. Apply sparingly not under clothing and only when necessary. Reapply after 6 hours if necessary. Hold container upright and spray clothing and exposed skin except face. TO APPLY TO FACE: Spray hands and apply avoiding eyes and mouth. Do not spray in enclosed spaces.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. CONTENTS UNDER PRESSURE. Do not place in hot water or near radiators, stoves or other sources of heat. Call a poison control centre or doctor for treatment advice. If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL: When container is empty, press button to release all pressure then dispose in household garbage.
