Avoid spray drift to any desirable vegetation NOT listed on this label as damage may occur. Avoid contamination of ponds, streams, rivers, lakes and other water sources. Do not spray during periods of high winds when spray is likely to drift. Coarse sprays are less likely to drift. Do not spray during periods of high temperatures when crops may be under stress as damage to the crop may occur.

#### TIMING:

For best results spray when weeds are in the seedling stage. Apply in good growing conditions. Application *must* be made before the crop shields the weeds.

#### **SPRAYER:**

Half fill the tank with clean water. Add the required amount of IPCO LEADER 450 LIQUID HERBICIDE and agitate thoroughly. Fill the tank and agitate again before use.

Seasonal water bodies require buffer zones if there is water in them during application. Water bodies which do not fill on an annual basis need not be buffered.

\* For field sprayer application, buffer zones can be reduced with the use of drift reducing spray shields. When using a spray boom fitted with a full shield (shroud, curtain) that extends to the crop canopy, the labelled buffer zone can be reduced by 70%. When using a spray boom where individual nozzles are fitted with cone-shaped shields that are no more than 30 cm above the crop canopy, the labelled buffer zone can be reduced by 30%.

When a tank mixture is used, consult the labels of the tank-mix partners and observe the largest (most restrictive) buffer zone of the products involved in the tank mixture.

#### HERBICIDE RESISTANCE MANAGEMENT:

For resistance management, please note that IPCO LEADER 450 LIQUID HERBICIDE is a Group 4 and 6 herbicide. Any weed population may contain or develop plants naturally resistant to IPCO LEADER 450 LIQUID HERBICIDE and other Group 4 and 6 herbicides. The resistant biotypes may dominate the weed population if these herbicides are used repeatedly in the same field. Other resistance mechanisms that are not linked to site of action, but specific for individual chemicals, such as enhanced metabolism, may also exist. Appropriate resistance-management strategies should be followed.

To delay herbicide resistance:

- Where possible, rotate the use of IPCO LEADER 450 LIQUID HERBICIDE or other Group 4 and 6 herbicides with different herbicide groups that control the same weeds in a field.
- Use tank-mixtures with herbicides from a different group when such use is permitted.
- Herbicide use should be based on an IPM program that includes scouting, historical information related to herbicide use and crop rotation, and considers tillage (or other mechanical), cultural, biological and other chemical control practices.
- Monitor treated weed populations for resistance development.
- Prevent movement of resistant weed seeds to other fields by cleaning harvesting and tillage equipment and planting clean seed.

#### SPRING WHEAT AND BARLEY (not underseeded to legumes)

**Spray Volume and Pressure:** For ground application, apply in 50 to 100 L of water per hectare at a pressure of 275 kPa. For aerial application, apply in a minimum of 30 L of water per hectare. For best results when there is a heavy crop canopy, or when the majority of the weeds are cow cockle, smartweed or pigweed, a volume rate of 40 L/ha is recommended.

**Timing**: Spring wheat and barley may be treated from the 4-leaf stage until the early flag leaf stage. Application before the 4-leaf stage may injure the crop.

#### Application Rate: 1.25 L/ha

Do not apply more than once per year.

#### **Pre-Harvest Interval:**

• Do not permit livestock to graze fields within 30 days after application.

- Do not harvest forage or cut hay within 30 days after application.
- Withdraw meat animals from treated fields at least 3 days before slaughter.
