FIRST AID

IN CASE OF POISONING, contact a physician or a poison control centre **IMMEDIATELY**. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION

This product contains a petroleum distillate. Vomiting may cause aspiration pneumonia. If ingestion has occurred less than 2 hours earlier, carry out careful gastric lavage. Treat symptomatically.

Treat symptomatically for skin and eye irritation.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN.

Do not breathe spray mist. Keep product away from fire, open flame, lighted electric bulbs and other sources of heat. Do not allow water to be introduced to contents of this container. May cause skin and eye irritation. Do not get on skin or in eyes. Wear chemically resistant gloves when handling.

STORAGE

Store away from food and feed and all sources of heat. Keep container closed. Do not allow water to be introduced to the contents of this container.

SPILL CLEANUP

1. Spread a suitable absorbent such as clay or other absorbent on the liquid.
2. Place sweepings in an open drum.
3. Generously cover the contaminated area with a common household detergent. Using a stiff brush, work the detergent into the spill material using sufficient water to form a slurry. Brush the slurry into cracks and crevices, and allow to stand for 2 to 3 minutes.
4. Spread a suitable absorbent such as clay or other absorbent on the slurried liquid, and shovel the absorbed material into an open drum.
5. Repeat if necessary.
6. Flush area with water, while observing proper environmental precautions.
7. Seal drum and dispose of contaminated material in accordance with municipal or provincial recommendations. See DISPOSAL section.

DISPOSAL

For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean up of spills.

CONTAINER DISPOSAL:

FOR RECYCLABLE CONTAINERS:

Do not reuse this container for any purpose. This is a recyclable container, and is to be disposed of at a container collection site. Contact your local distributor/dealer or municipality for the location of the nearest collection site. Before taking the container to the collection site:

1. Triple- or pressure-rinse the empty container. Add the rinsings to the spray mixture in the tank.
2. Make the empty, rinsed container unsuitable for further use.

If there is no container collection site in your area, dispose of the container in accordance with provincial requirements.

FOR REFILLABLE CONTAINERS:

For disposal, this container may be returned to the point of purchase (distributor/dealer). It must be refilled by the distributor/dealer with the same product. Do not reuse this container for any other purpose.

DIRECTIONS FOR USE

TURBOCHARGE 2 Adjuvant must always be used with ACHIEVE Liquid Herbicide, Liquid ACHIEVE SC Herbicide, or ACHIEVE 40SC Herbicide. Use as a 0.5% v/v adjuvant (0.5 L TURBOCHARGE 2 Adjuvant per 100 L of spray mixture). Refer to the ACHIEVE Liquid Herbicide, ACHIEVE 40SC Herbicide or Liquid ACHIEVE SC Herbicide label for further details on rate of use and mixing instructions.
