BACK LABEL

Tablets should be used in toilets that are flushed regularly.

For best results, clean toilet thoroughly first, including under the rim. Do not touch tablet directly.

DIRECTIONS FOR USE:

To Clean, Deodorize and Sanitize:

Remove tank cover. Flush toilet. When water level is low, drop tablet in tank near side wall closest to float and away from water valve opening or right rear corner of the tank. Each tablet sanitizes for 7 weeks. When tablet has dissolved, replace with a new tablet.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. HARMFUL IF SWALLOWED. HIGHLY CORROSIVE. DO NOT TAKE INTERNALLY. Corrosive to eyes and skin. Irritating to nose and throat. Avoid breathing dust. Use with adequate ventilation. Do not get into eyes, on skin or clothing. Potential skin sensitizer. It is recommended to wear rubber gloves and goggles when handling the product. Wash thoroughly after handling.

FIRST AID:

If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

For skin or clothing contact, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If swallowed call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

This product is corrosive to skin and eyes and may produce a sensitization response or allergic reaction in some individuals. Probable mucosal damage may contraindicate the use of gastric lavage.

PHYSICAL AND CHEMICAL HAZARDS:

Strong oxidizing agents. Mix only with water. Do not mix with other chemical products as this may result in fire or explosion. In case of contamination or decomposition do not reseal container. If possible, isolate container in open air or well ventilated area, if necessary flood with large volumes of water.

STORAGE: Store in original container, in a cool, dry, well-ventilated area. Keep out of reach of children. Do not store at elevated temperatures.

DISPOSAL: Discard empty container in household trash. Do not reuse package. Empty any residue material into the toilet and flush.
