DIRECTIONS:

Glyphosate is not to be applied using hand-wicking or hand-daubing methods.

HOW TO APPLY:

- Turn nozzle to desired position - FOAM or STREAM. FOAM marks weeds for up to 5 minutes, allowing you to easily see where you've sprayed. STREAM provides coarse spray that does not foam. Spray the weeds or grasses you want to eliminate until thoroughly covered with foam or liquid.
- For best results ensure that Roundup® Ready-to-use Poison Ivy & Bush Control Non-Selective Herbicide gets down to the roots - avoid tillage or disturbing the treated area for 7-10 days. This will ensure that the entire plant, including the root, is eliminated.
- Avoid spray contact on desirable plants as any plant contacted may be killed. When spot treating around desirable plants, shield plants from drift with a piece of cardboard or plastic. If a desirable plant is accidentally sprayed, rinse off immediately with water.
- Do not apply to the point of run off.

WHERE TO APPLY:

IMPORTANT: Do not spray plants or grasses you like - they may die too. Not recommended for spot weed control in lawns since Roundup® Ready-to-use Poison Ivy & Bush Control Non-Selective Herbicide kills lawn grasses.

- **Poison ivy:** Apply to vigorously growing plants. Apply after seed heads, flowers or berries appear.
- **Brush control:** Apply after leaves are fully expanded. Treat trees and brush up to 1.5 m in height only; for taller plants cut down and spray regrowth.
- **For lawn and garden renovation,** skip one mowing prior to treatment. Allow at least 3 days after treatment before disturbing the soil and/or replanting.

WHEN TO APPLY:

- Apply when weeds and grass are actively growing. Apply to annual weeds anytime after emergence. For perennial weeds apply after seed heads, flowers or berries appear.
- For best results, apply during warm, sunny weather (above 15°C) to accelerate systemic movement from foliage to roots.
- Apply when air is calm to prevent drift to desirable plants.
- Do not apply if rainfall is forecast for the time of application. Rain-Proof™ - Rain or watering two hours after application will not wash away effectiveness. However, heavy rainfall immediately after application may wash the chemical off the foliage and repeat treatment may be required.
- All ornamental flowers, trees & shrubs may be planted **1 day after** application.

WHAT TO LOOK FOR:

- Visible symptoms of control, such as browning or yellowing of leaves, will occur within 1 to 2 days with complete control in 7 to 10 days.

HOW IT WORKS:

- Roundup® Ready-to-use Poison Ivy & Bush Control Non-Selective Herbicide is a non-selective vegetation control herbicide which controls poison ivy and brush, as well as most annual and perennial grasses, including lawn grasses & broadleaf weeds (i.e. virtually anything that is green and growing). Roundup® Ready-to-use Poison Ivy & Bush Control Non-Selective Herbicide enters plants through foliage and moves systemically to the roots, eliminating weeds by stopping the production of a substance found only in plants.
- **NOTE:** ROUNDUP® Ready-to-use Poison Ivy & Bush Control Non-Selective Herbicide has no soil activity and will not leach or run off to affect nearby vegetation. Controls only growing or emerged grasses and weeds. Repeat applications will be required as new seedlings and vegetation emerge.

PRECAUTIONS:

CAUTION: EYE IRRITANT. HARMFUL IF SWALLOWED. Avoid contact with eyes or prolonged contact with skin. Do not allow others such as children and pets on treatment area during application or to re-enter treated areas until spray has dried. Wash immediately after using this product. Do not contaminate water, foodstuffs, seed or feed by storage or disposal.

FIRST AID:

If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. **If swallowed,** call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. **If in eyes,** hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. TOXICOLOGICAL INFORMATION:

Treat symptomatically.

STORAGE:
