Site preparation:

For best results, remove all remnants of existing vegetation or unwanted plant growth. Rake and smooth the soil before installing the fabric.

Installation of the textile fabric (rolls):

Can be installed in the soil vertically, horizontally, or as a surround. Simply install/unroll the material to the desired length and (if necessary) cut using scissors. When overlapping is necessary, we suggest a 10-15 cm (4 to 6 inch) overlap. It is recommended to clean the TEX-R RC6 PRO thoroughly before covering it with any material. The glazed surface of the fabric must be upward and should not be installed facing the ground.

Covering the textile fabric:

Cover Tex-R RC6 PRO textile fabric completely with a 2.5-5 cm (1-2 inch) layer of "sterile" material to protect it against the sun.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid contact with skin and eyes.

Wear chemical-resistant gloves, eye goggles, long pants, a long-sleeved shirt and shoes plus socks during handling, application, and clean-up.
