To be used only in the manufacture of a herbicide which is registered under the *Pest Control Products Act*.

PRECAUTIONS

FIRST AID

Do not give anything by mouth to an unconscious person. **If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth, if possible.
