GENERAL INFORMATION:

ZODIAC SPOT ON II Flea Control for Cats and Kittens provides relief from flea infestations for up to 4 weeks by killing flea eggs laid on your pet, thereby, effectively breaking the flea life cycle. Adult fleas spend virtually all of their time on the pet and produce vast numbers of eggs that drop off the pet and develop in the environment. *ZODIAC SPOT ON II Flea Control for Cats and Kittens* is designed to kill flea eggs, thereby breaking the flea life cycle.

DIRECTIONS FOR USE: Do not use on cats or kittens under 12 weeks of age. Do NOT

administer by mouth. Consult a veterinarian before using sick, aged, pregnant or nursing animals or animals receiving drug or other pesticide treatment.

This package contains four 1 mL doses.

1. Bend at perforation and tear off one applicator. 2. Hold applicator and bend numbered area of plastic at perforation, tear off and discard. 3. Hold applicator upright away from face and body and use scissors to cut secure seal applicator tip. 4. Prior to application of the product, gently lift the cat's haircoat on the back of the neck at the base of the skull, position the tip of the applicator on the cat's exposed skin and squeeze out the entire contents of the applicator onto the cat's skin.

Do not reapply product for 4 weeks. Reapply every 4 weeks for continual pest control in situations where there is an ongoing risk of pest infestation. Treatment must only be repeated if pest problem reoccurs. RETAIN PACKAGING INFORMATION FOR FUTURE REFERENCE.

After application, *ZODIAC SPOT ON II Flea Control for Cats and Kittens* will spread over the cat's body to provide protection against subsequent flea infestations originating from the surrounding environment. Discontinue use if adverse effects are observed. If condition persists, consult your veterinarian. A veterinarian should be consulted when pest infestation continues to be a problem on the pet.

ZODIAC SPOT ON II Flea Control for Cats and Kittens is most effective when used as part of a total program aimed at reducing fleas in the cat's environment. For effective flea control, treatment of the cat should be combined with the sanitation of any area used by the cat. Vacuum floor, carpets and furniture (discard vacuum bag after use) and wash the cat's bedding, living quarters, and surrounding areas. ZODIAC flea control products are designed to complement each other in an integrated program for flea and tick management. If pest problems persist, an insecticidal premise treatment (e.g. ZODIAC Premise Sprays) may be required. This product contains (S)-Methoprene. Do not apply another pest control product such as a shampoo, collar, or powder that contains (S)-Methoprene to the treated animal after applying *ZODIAC SPOT ON II Flea Control for Cats and Kittens*.

PRECAUTIONS:

HUMANS:

KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. Wear rubber gloves when applying. Avoid contact with skin or eyes. Avoid contact with pets until dry.

After handling or applying, wash hands (or any other skin that came into contact with the product) with soap and water. Avoid product contact with food, food utensils or places where food is prepared or stored. **PETS:** Harmful if swallowed. Avoid contact with cat's mouth, face, eyes and genitals. Care should be taken to prevent exposure of other pets who may be in close physical contact with the treated animal. Sensitivities may occur after using any pesticide for pets.

Smaller animals are more likely to experience an adverse reaction. Observe carefully.

Side Effects: Monitor your cat after application. Side effects may include: skin irritation such as scratching or hair loss at the application site, or changes in behaviour such as agitation or lethargy. Gastrointestinal effects such as drooling, vomiting, or loss of appetite may also occur. If these or other side effects occur consult your veterinarian or Wellmark International at 1-800-688-7378.

FIRST AID: HUMANS:

IF SWALLOWED, Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF IN EYES, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF ON SKIN OR CLOTHING, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

PETS: If signs of sensitivity occur bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical or veterinary attention.

STORAGE: Store in a cool, dry place.

TOXICOLOGICAL INFORMATION: Treat symptomatically

DISPOSAL: Do not reuse empty container. Wrap and dispose of empty container with household garbage.
