DIRECTIONS FOR USE:**OILFIELD APPLICATIONS:**

Use 100 ppm active ingredient based on the water content of oil and gas field water systems until bacterial control is achieved. Inject at a point that will ensure uniform mixing. Maintenance dosage 10 – 25ppm.

FIRST-AID:

IF SWALLOWED - call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF ON SKIN OR CLOTHING - take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

IF INHALED - move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
