DIRECTIONS FOR USE:

POOL DROPS LIQUID ALGICIDE PLUS 6% prevents algae growth in water. When applied to contaminated pools, POOL DROPS LIQUID ALGICIDE PLUS 6% will kill algae gradually (over several days).
