APPLICATION INSTRUCTIONS FOR HORSES (AND PONIES):

Use Limitations:

- FOR USE ON HORSES (AND PONIES) ONLY. DO NOT** use on newborn or nursing foals. /.
- Use on Show, Race, Work or Pleasure Horses only. **DO NOT** use on horses intended for slaughter.
- DO NOT** soak skin. **DO NOT** apply more than 60 ml. per animal per treatment.
- DO NOT** spray directly to mouth, face, eyes or genitals of the animal.
- DO NOT** cover horses/ponies immediately after treating/after treatment.

HORSES AND PONIES

Repels listed pests for up to 17 days. Repels and controls house flies, stable flies, horn flies, face flies, horse flies, deer flies, black flies, and mosquitoes.

DIRECTIONS FOR USE:

Prior to treatment, thoroughly brush horse/pony to remove excess dirt and dust and remove mucous secretions from face of the horse/pony. Extremely dirty horses should be shampooed, rinsed and allowed to dry before treatment.

HOLD CONTAINER UPRIGHT. SHAKE WELL BEFORE USING. Ready to use. No mixing necessary. Product only applied as a wipe-on. After shaking, remove cap and wipe the sponge tip of the bottle on the face and other body regions, such as back, belly, ear and leg regions, where the specific attacking pests feed or gather. Thoroughly rub the sponge tip over the area of hair of the horse/pony to be protected. It is best to apply by rubbing against the hair growth. Pay special attention to the legs, shoulders, shanks, neck and facial areas where flies most often are seen. Replace cap after use. After application, brush thoroughly to bring out bright sheen on the coat.
