DIRECTIONS FOR USE

POLYMER LATEX PRESERVATION

This product is recommended for the control of bacteria and fungi in the manufacture and storage of synthetic and natural polymer latices. Add 0.103% of this product to provide 100 ppm active ingredient. To insure uniform distribution, slowly disperse this product into product with agitation. Mix thoroughly until evenly dispersed throughout product.

MINERAL DISPERSION PRESERVATION

This product is recommended for the control of bacteria and fungi in the manufacture and storage of mineral dispersions. Add 0.026% - 0.052% of this product to provide 25-50 ppm active ingredient. To insure uniform distribution, slowly disperse this product into product with agitation. Mix thoroughly until evenly dispersed throughout product.

It is recommended the formulator test within the range of rates on the label to determine an effective rate for their specific product.
