**DIRECTIONS FOR USE:**

To be used only in the manufacture of an herbicide, which is registered under the Pest Control Products Act.

**PRECAUTIONS:****KEEP OUT OF REACH OF CHILDREN AND PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.**

Avoid contact. Avoid breathing technical dust or fumes. Wash thoroughly after using or before eating or smoking. Wear protective clothing including goggles and respirator when handling technical material.

**FIRST AID:**

IN CASE OF POISONING, contact a physician or a poison control centre **IMMEDIATELY**. Remove the patient from contaminated area. Keep the patient at rest.

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:**

The treatment of intoxication should be symptomatic and supportive. When the technical has been ingested, carry out gastric lavage with care to prevent aspiration.

**DISPOSAL AND DECONTAMINATION:**

Canadian formulators of this technical should dispose of unwanted active and containers in accordance with municipal or provincial regulations.
