DIRECTIONS FOR USE

To be used only in the manufacture of a pesticide which is registered under the *Pest Control Products Act*.

PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Harmful if absorbed through skin or inhaled. Avoid contact with skin, eyes or clothing. Avoid breathing vapours. Thoroughly wash with soap and water after handling. Potential skin sensitizer. May cause eye irritation. Causes skin and mucous membrane irritation. The handling of limonene, as well as the clean-up and maintenance activities should be performed in a well ventilated area.

FIRST AID

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on Skin or Clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 – 20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eyes open and rinse slowly and gently with water for 15 – 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

Treat symptomatically.
