This product's patented blend provides the perfect solution for clear inviting pool water. Shock treatment is needed when bather loads are high, water appears hazy or dull, unpleasant odours or eye irritation occurs, or after heavy rain.

DIRECTIONS FOR USE:

Maintain daily levels as determined by test kits:

Free available chlorine: 1-3 ppm

pH: 7.4-7.6

Total alkalinity: 100-120 ppm

Calcium hardness: 200-300 ppm
200-275 ppm (plaster)

Application Method:

With the pool pump in operation, broadcast the product evenly into the deep end of the pool. Operate recirculation pump for 12 hours after product addition. In pools with potentially bleachable surfaces such as vinyl, paint, fiberglass, or colored plaster, brush any undissolved product from pool surfaces.

NEVER ALLOW UNDISSOLVED PRODUCT TO REST IN CONTACT WITH BLEACHABLE POOL SURFACES.

NOTE: In shallow pools with a depth less than 4 feet or when water is less than 18° C, Pre-dissolve this product and apply evenly around the edge of the pool. Dissolve this product outdoors in a clean plastic bucket, stirring with a clean plastic or wooden spoon. Add this product to water; **NEVER** add water to product. **NEVER** add more than 400g of this product to less than 12 litres of cool water.

Pool should not be entered until the chlorine residual is 1.0-3.0 ppm

INITIAL START-UP: Add 200 g of BioGuard BurnOut Extreme per 10,000 litres of pool water. For best results, superchlorinate at dusk.

ROUTINE CHLORINATION: Maintain 1-3 ppm chlorine residual by broadcasting daily over the pool's surface, 40 g of this product per 10,000 litres of pool water, or as needed. **Note:** Hot weather, heavy pool usage, and rain may require higher usage rates to maintain proper chlorine residuals.

SHOCK TREATMENT: Superchlorinate weekly and using 200 g of this product per 10,000 litres of pool water when average daily temperature is 25°-32°C. Otherwise, superchlorinate every other week.

ALGAE TREATMENT: For visible algae, superchlorinate using 500 g of this product per 10,000 litres of pool water. Heavy algae infestation may require dosages up to 700 g of this product per 10,000 litres of pool water. Vacuum pool when dead algae settles.

PRECAUTIONS: CORROSIVE to the eye and skin. DO NOT get in eyes or on skin. KEEP OUT OF REACH OF CHILDREN. Strong oxidizing agent. May cause fire or explosion if contaminated.
