**CRAWLING INSECTS:** Ants, Carpet Beetles, Centipedes, Cockroaches, Crickets, Fleas, Silverfish, Earwigs, and Spiders. Contact as many insects as possible with the spray in addition to thorough spraying of all parts of the room suspected of harboring these pests. Special attention should be paid to cracks, hidden surfaces under sinks, behind stoves and refrigerators, storage areas and wherever these pests are suspected of hiding. To kill ants, treat doors, around window frames, ant trails and other areas of entry. Repeat as required. **FLEAS:** Spray animal sleeping quarters and floors around area, but not furniture or carpets that people regularly contact. Remove old bedding and replace with clean bedding after treatment. DO NOT SPRAY PETS. For other insects listed above spray around doorframes and window frames both indoors and outdoors.

**HOUSEPLANT PESTS**: Kills Ants, Aphids, Caterpillars, Leafhoppers, Spiders, Whiteflies, Mealybugs, and Spider Mites on houseplants such as Ivy, African violets, Impatiens, Geraniums and Begonias. Hold container 45 to 60 cm from plants being sprayed. Cover upper and lower surfaces of leaves. Avoid wetting foliage with spray. Use short bursts of 1 second for spot application on new growth. Use caution on young plants and new growth.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed or absorbed through skin. Contains petroleum distillate. Do not breathe vapors or spray mist. Avoid contact with skin or eyes. Wash hands with soap and warm water after use. DO NOT SPRAY PETS OR OTHER ANIMALS WITH THIS PRODUCT. Avoid contamination of foodstuffs. Do not use in commercial food processing or preparation areas. In the home, all processing surfaces and utensils should be covered during treatment, or thoroughly washed and rinsed before use. Remove or cover exposed food. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre of doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically. CONTAINS PETROLEUM DISTILLATE. Vomiting may cause aspiration pneumonia.

**STORAGE:** Store in a cool dry area away from heat or open flame.
