Protects above ground wood structures, beams, doors, steps, posts, millwork, fences, windows, plywood, etc. against rot, swelling and warping of wood.

#### DIRECTIONS FOR USE:

For exterior use only. For above ground use only. Not for use in dwellings. Apply by brush only. Do not spray or dip.

DO NOT apply using an airless sprayer.

DO NOT apply this product to wood that will be used in water.

Do not use the preservative or treated wood where copper naphthenate may contaminate food, feed or drinking water.

DO NOT discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans and other waters.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

Wood surface to be treated should be dry and clean. Remove all paint, varnish, wax, or any other coating that may prevent penetration. Allow to dry thoroughly before painting or re-coating. Use one coat on material to be finished with paint or stain. If no finish is to be used, apply two coats within the hour. Thoroughly cover ends. Use caution with some paint finishes as they may cause bleeding. Use as supplied – do not dilute. Do not apply to wood or fabric or any surface where prolonged skin contact may occur. May be used on greenhouse and garden timbers in close contact with non-food producing plants only. Carrier solvent must be allowed to dry before introducing plants to prevent phytotoxicity. Clean equipment with mineral spirits, then with detergent and water.

Spreading rate: 1 litre covers about 6 to 8 square meters (65 – 85 square feet). Varies according to the texture and porosity of the surface.

For fabric use: For use only on exterior industrial fabric. Apply by brush or swab only. Do not spray or dip. Do not use on rubber coated fabric.

#### PRECAUTIONS

##### KEEP OUT OF REACH OF CHILDREN

This product is to be used only for the remedial treatment of exterior industrial wood products having no opportunity for prolonged or direct skin contact with people or animals, or contact with food, feed or drinking water. This product is not to be used in children's playground equipment. Flammable. Do not use or store near open flame or spark or in areas subject to excessive heat. Avoid breathing vapours. Harmful if swallowed or inhaled. Use a cartridge respirator appropriate for the job conditions, eg, poorly ventilated areas or applying copper products by brush. Wear long-sleeved shirt, long pants, elongated chemical resistant gloves, chemical resistant footwear and protective eyewear in case of splash hazard, when applying this product. Wash thoroughly after use with soap and water and before eating or smoking. Keep container closed when not in use. May cause skin and eye irritation. Potential skin sensitizer. Do not get in eyes, on skin or on clothing.

#### ENVIRONMENTAL PRECAUTIONS:

Toxic to aquatic organisms. This product contains a petroleum distillate which is moderately to highly toxic to aquatic organisms. Avoid contamination of aquatic systems during application.

**FIRST AID:**

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**TOXICOLOGICAL INFORMATION:**
