DIRECTIONS FOR USE:

To be used only in the manufacture of a herbicide which is registered under the *Pest Control Products Act*.

PRECAUTIONS:**PREVENT ACCESS BY UNAUTHORIZED PERSONNEL**

May irritate eyes, nose, throat and skin.

Avoid breathing dust.

Avoid contact with skin, eyes or clothing.

Wash thoroughly with soap and water after handling.

TOXIC to aquatic organisms.

DO NOT discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters.

FIRST AID:

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

No specific antidote. Employ supportive care. Treatment should be based on judgment of the physician in response to the reaction of the patient.

DISPOSAL:

Container should be emptied into processing equipment by shaking and tapping sides and bottom to loosen clinging particles. Canadian manufacturers should dispose of unwanted active ingredients and containers in accordance with municipal or provincial regulations. For additional details and cleanup of spills, contact the manufacturer or the provincial regulatory agency. If spilled, recover all possible product and use if not contaminated. Recover remainder and dispose of as indicated above.
