WHY TO USE THIS PRODUCT: For use in feeders, floaters or skimmers, this multifunctional sanitizer kills bacteria and controls algae. Aqua Chem Multi-Tabs contain a metal stain inhibitor, scale preventer and water softening agent. This sanitizer will last longer compared to chlorine products such as liquid bleach or calcium hypochlorite, as it contains sunlight-protected chlorine. It's the perfect solution for clear, inviting pool water.

Warning: Direct tablet contact may cause bleaching of vinyl or painted pool surfaces. Automatic feeding devices employing these tablets must be totally free from traces of other pool sanitizers to avoid the probability of an explosion.

DIRECTIONS FOR USE:

- Do not enter the pool if free available chlorine is above 3 ppm as determined by testing kit.
 Free available chlorine: 1.0 3.0 ppm pH: 7.2 7.8 Total Alkalinity: 100 - 120 ppm Calcium Hardness: 200 - 300 ppm
- **2.** For outdoor pools, chlorine residuals can be protected from destruction by the sun's rays by adding 300 g of stabilizer (cyanuric acid) per 10,000 L of pool water to yield the required initial concentration of 30 ppm.
- **3.** Periodic superchlorination of pool water is recommended. Follow label instructions of superchlorinating product being employed.
- **4.** This product contains stabilizer which can accumulate in pool water. Keep stabilizer within the range of 30 100 ppm by dilution with fresh water.
- 5. If using an automatic chlorinator, fill the chamber(s) with tablets and adjust flow rate, according to manufacturer's recommendations, to maintain proper chlorine residual. Adding tablets to the pool's skimmer basket is an alternative chlorine feed method. Daily usage should approximate 30 g of Aqua Chem Multi-Tabs per 10,000 L of pool water.

Note: Hot weather, heavy pool usage, and rain may require higher usage rates to maintain proper chlorine residuals.
