FIRST AID

IF IN EYES: Hold eye open and rinse slowly and gently with water for 30 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor immediately for treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

TOXICOLOGICAL INFORMATION

STORAGE AND HANDLING

To prevent contamination store this product away from food or feed. UCARCIDE™ 225 Preservative solutions are incompatible with many commonly used materials of construction such as steel, galvanized iron, aluminum, tin and zinc. These solutions can be stored and handled in baked phenolic-lined steel, polyethylene, stainless steel, or reinforced epoxy-plastic equipment. This product freezes at about -10°C. Therefore, unless the storage tank is inside or underground, heating and insulation may be required. If heating is needed, exposure to high temperatures should be avoided. For short storage times (up to about 1 month), temperatures of up to 38°C can be tolerated but the preferred maximum storage temperature is about 27°C.

A stainless steel centrifugal pump is suggested for transfer service. Spiral wound stainless steel with TEFLON® is suitable for gaskets and packing.

DISPOSAL:

1. Triple or pressure-rinse the empty container. Add the rinsings to the treatment site.
2. Follow provincial instruction for any required additional cleaning of the container prior to its disposal.
3. Make the empty container unsuitable for further use.
4. Dispose of the container in accordance with provincial requirements.
5. For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.

DO NOT discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters.

UCARCIDE™ 225 Preservative is recommended for use in aqueous or water containing products and systems, including industrial, institutional and consumer pesticide products, in-can processes and products to control the growth of bacteria and fungi. For effective preservation, add UCARCIDE™ 225 Preservative to the product formulation at a rate of 400 to 4,000 ppm based on the water content of the product (0.4 to 4.0 gr UCARCIDE™ 225 Preservative /Kg water content). Mix uniformly.

When used as an in-can preservative in which paints may be applied in a residential setting, the maximum application rate for paints is 100 ppm.
