**HTH Triple Action Chlorine Tablets** are slow dissolving products that control algae, kill bacteria and destroy organic contaminants. These tablets are designed to be used in the skimmer basket or in a floater or feeder.

#### **DIRECTIONS FOR USE:**

**WATER BALANCE:** Maintain recommended daily levels as **determined by testing kit**: Free available chlorine between 1.0 - 3.0 ppm, pH in 7.2 - 7.8 range, Total alkalinity between 80 - 120 ppm, Calcium hardness between 200 - 300 ppm.

#### **METHOD OF APPLICATION**

**WARNING: Direct Tablet Contact may Cause Bleaching of Vinyl or Painted Pool Surfaces.** To minimize bleaching, pre-dissolve required amount of **HTH Triple Action Chlorine Tablets** in a plastic pail with concentration not exceeding 1 kg per 10 L of water. Always add chemical to water, **NEVER** water to chemical. Broadcast resulting slurry directly to pool water. **Skimmers and Automatic Feeding Devices Containing These Tablets Must Be Totally Free from Traces of other Pool Sanitizers To Avoid the Probability of an Explosion.**

**SKIMMER USE:** Add the recommended amount of this product to the skimmer basket using a clean, dry scoop. DO NOT use the scoop for any other purpose. NOTE: Remove any other chemical/chemical residue from skimmer basket before adding recommended amount of this product to prevent dangerous chemical reactions or possible explosions.

**FLOATER/FEEDER USE:** Only use in a floater or feeder that is new or previously contained only this product. If the floater or feeder is equipped with adjustable chamber, set the openings to allow maximum water flow past the tablets.

**DOSAGE:** One tablet weighs approximately 7 g.

**POOL OPENING:** Add 220 grams (approximately 35 tablets) per 10,000 litres of pool water

**ROUTINE CHLORINATION:** **Test water daily and adjust to maintain 1 to 3 ppm free available chlorine residual. Typically, 90 grams of this product (approximately 15 tablets) per 10,000 Litres of pool water is needed to maintain recommended chlorine level. If your pool is stabilized, use 45 grams of this product (approximately 8 tablets) per 10,000 Litres of pool water every other day. When tablets are completely dissolved, replace with new tablets as needed.** NOTE: Hot weather, heavy pool usage, and rain may require higher usage rates to maintain proper chlorine residuals.

**SHOCK TREATMENT:** Shock treat your pool weekly using HTH or Sock It brand **granular** products to prevent pool problems. Follow label directions on those products. For visible algae, shock using 500 g of **HTH Triple Action Chlorine Tablets** per 10,000 L of pool water. Heavy algae infestation may require dosages up to 725 g per 10,000 L. Vacuum pool when dead algae settles.

**NOTE:** For outdoor pools, chlorine residuals can be protected from destruction by sun's rays by addition of stabilizer (cyanuric acid).

**PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN.**

DANGER: Corrosive. Causes skin and eye damage. May be fatal if swallowed. Do not get in eyes, on skin, or on clothing. Do not handle with bare hands. Wear eye protection, protective clothing and use rubber gloves when handling this product. Use only thoroughly clean, dry utensils when handling. Irritating to nose or throat. Avoid breathing dust and fumes. Remove and wash contaminated clothing before reuse.

**FIRST AID:**

**IF SWALLOWED**, call a poison control centre or doctor immediately for treatment advice.

Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**IF ON SKIN OR CLOTHING**, take off contaminated clothing. Rinse skin immediately with plenty of water for 15~20 minutes. Call a poison control centre or doctor for treatment advice.

**IF INHALED**, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**IF IN EYES**, hold eye open and rinse slowly and gently with water for 15~20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Probable mucosal damage may contraindicate the use of gastric lavage. Have the product container or label with you when calling a poison control centre or physician, or going for treatment. Treat symptomatically.

DO NOT use this product with any other chlorinating compound.

DO NOT place in skimmer baskets that contain undissolved material or residue from previously used tablets or sticks.

DO NOT use this product in any floater or feeder which has previously contained other chemicals.

**CHEMICAL HAZARDS: DANGER.** Strong oxidizing agent. Dangerous gas formed when mixed with acid.

Add only into water. Use only clean dry utensils to dispense this product. Do not use this product in a container or dispensing device that has been used with any other product. Keep all foreign matter, including other pool treatment products, away from this product. Do not allow to become wet or damp before use. Contamination may start a chemical reaction that can give off heat and hazardous gases and may cause a fire or explosion. Do not touch this chemical with a flame or burning material (like a lighted cigarette).

#### **STORAGE & DISPOSAL**

- Keep this product dry in its tightly closed container when not in use.
- Store in a cool, dry, well-ventilated area.

- Do not reuse empty container.
- Rinse empty container thoroughly with water to dissolve all material and discard container in trash.
- Do not contaminate food or feed by storage or disposal or cleaning of equipment.
- For disposal of a contaminated or decomposing product, see Emergency Handling.
- For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.

**EMERGENCY HANDLING:** In case of contamination or decomposition:

1. Do not reseal container.
2. Immediately remove container to an open and well-ventilated outdoor area by itself.
3. Flood with large amounts of water until the material is dissolved.
4. Dispose of container and any remaining material in an approved landfill area.
