DIRECTIONS FOR USE:

- 1. Initial dosage for pool water having no visible algae is 200 mL per 10,000 liters of pool water.
- 2. Weekly maintenance dosage is 70 mL per 10,000 liters of pool water.
- 3. For pool water having visible algae, superchlorinate following label instructions of superchlorination product employed and wait for at least 24 hours before adding weekly maintenance dosage.
- 4. For visible algae growth, when superchlorination product is not employed, add 300 mL per 10,000 liters of pool water.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN

Harmful if swallowed. Do not mix with any other chemical. Avoid contact with skin and eyes. Rinse container thoroughly before discarding. Do not reuse.

FIRST AID:

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL

Do not re-use empty container. Wrap and dispose of empty container with household garbage.
