DIRECTIONS: Use ONLY in a well ventilated area, preferable outdoors. SHAKE WELL BEFORE USING. Hold can upright at least 120 cm from all objects and aim nozzle away from person. Press button firmly to spray. Do NOT use this spray more often than once every week. Treatment must only be repeated only if the pest problem persists or reoccurs.

TO KILL INDOOR PESTS:

Flying Insects: Flies, Mosquitoes, Hornets, Wasps, Biting Midges and Flying Moths. Close doors and windows. Direct mist upwards in circular sweeping motion to all parts of the room especially windows and other light sources. Apply 6-10 seconds burst per 30m³ of space. Whenever possible, keep doors and windows closed for 15 minutes after each treatment. Also direct mist into areas where insects are present. Keep spray at least 1m from interior wall, fabrics and furniture. Spray directly on insects for fastest action.

Crawling Insects: Cockroaches, Ants, Spiders, Silverfish, Crickets, Centipedes & Carpet Beetles. Spray THOROUGHLY into hiding places such as cracks, crevices, openings around sinks, drains and pipes, under refrigerators, baseboards, moist areas, behind cabinets and storage areas. **Ants:** Spray ant trails, around door sills, window frames, or in ant nests. Insects must be hit to be killed. **Bed Bugs:** Spray mattress lightly, particularly around seams and tufts. Take beds apart, spray bed frame and springs including all joints. Repeat as required. **Control Fleas & Brown Dog Ticks :** Spray infested areas such as pet's bed and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floor and floor covering where these pests may be present. Remove old bedding after treatment. Insects must be contacted to be killed.

Pests on Ornamental Plants: For control of Aphids, Two-spotted Spider Mites and Adult White Flies on the following plants: African Violets, Aralia, Christmas Cherry, Chrysanthemum, Cineraria, Diffenbachia, Fuschia, Gloxinia, Ivy, Lantana, Neathe Bella Palm, Petunia, Rose & Snapdragon. Spray when insects are noticed with a slow sweeping motion so that mist drifts on upper and lower leaf surface. Use with caution on new growth and tender foliage. Repeat as necessary.

TO KILL GARDEN PESTS: ON OUTDOOR FLOWERS AND ORNAMENTALS.

Sucking Insects: Exposed Thrips, Leaf-hoppers, Spotted Mites, Lacebugs, Aphids. **Chewing Insects:** Caterpillars, Climbing cutworms, Japanese Beetles, Mexican Beetles, Mealy Bug, Soft brown scale, Tent caterpillars, Canker worms & Garden webworms on Ornamental Crabapple, Cherries & Plum Tree. For insects on Asters, Azaleas, Begonias. Carnations, Camellias, Chrysanthemums, Dahlias, Delphiniums, Geraniums, Gladiolas, Irises, Marigolds, Petunias, Roses, Snapdragons, Evergreens, small Deciduous trees, shrubs and vines: Carefully spray with slow sweeping motion in short bursts at intervals to cover upper and lower surfaces of leaves. Keep 30 cm to 45 cm away from the plants to avoid wetting the foliage. A light spray kills pests effectively. Spray only when air is still and temperature is under 32°C. Do not spray in direct sunlight (direct sunlight will inactivate pyrethrins) - early morning or evening preferred. Use with caution on young plants and new growth. Insects must be contacted by spray to be killed .

On Vegetables: For insects on beans, broccoli, cabbage, carrots, cucumbers, eggplants, fruit trees, grapevines, onions, lettuce, peppers, potatoes, squash, tomatoes, & turnip .

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat, or store at temperatures over 50°C. Cover fish bowls and remove pets for one hour when spraying rooms. In homes or dwellings, remove or cover all food and cooking utensils before spraying. Avoid contact with skin eyes or clothing. Avoid inhalation of spray. Wash after using. Keep from freezing. Do not use on Maiden Hair ferns.

FIRST AID: In case of contact with eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. In case of contact with skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If accidentally swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL: When container is empty, press button to release all pressure then dispose in household garbage. This container may be recycled in communities where (steel) aerosol can recycling is available. Before offering for recycling, empty the can by using the product according to the label (DO NOT PUNCTURE OR INCINERATE). If recycling is not available, contact your municipality or provincial Ministry of Environment for disposal information.
