PRODUCT DESCRIPTION

Chontrol Paste is a biological herbicide for the inhibition of resprouting and regrowth from the cut stumps of red alder and sitka alder in rights-of way and forest vegetation management. This product will colonize the cut stump surface and will inhibit the resprouting and regrowth of red alder and sitka alder. Chontrol Paste inhibits resprouting of cut stumps by colonizing and decaying the stumps. This product will reduce the stem density of a treated site that is managed by mechanical brush cutting. The level of inhibition obtained may vary with the susceptibility of the target tree species and environmental factors which influence fungal growth and development. Chontrol is a paste formulation in one-litre squeeze bottles. One bottle of Chontrol Paste will treat approximately 200 stumps with a diameter of 2 to 6 cm on the cut surface.

DIRECTIONS

Apply Chontrol Paste to freshly cut stumps during the growing season, from late summer to early fall and when conditions are conducive for fungal growth and infection. Apply a thin layer of Paste on the entire surface of cut area within 30 minutes of cutting. Entire contents in the bottle must be used on the same day after opening. Do not mix Chontrol™ Paste with chemical pesticides including herbicides.

USE RESTRICTIONS

As this product is not registered for the control of pests in aquatic systems. DO NOT use to control aquatic pests.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wash water

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN. May cause sensitization. Avoid contact with eyes, skin or clothing. Wear a long-sleeved shirt, long pants, shoes plus socks and water-proof gloves when handling, mixing/loading or applying the product, and during all clean-up and repair activities. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

ENVIRONMENTAL PRECAUTIONS

To reduce runoff from treated areas into aquatic habitats, avoid application to areas with a moderate to steep slope, compacted soil or clay. Avoid application when heavy rain is forecast. Contamination of aquatic areas as a result of runoff may be reduced by including a vegetative filter strip between the treated area and the edge of the water body.

FIRST AID
