Not for daily use. Avoid applications to hands. In 2 to 12 years olds, do not apply than 3 times per day. **AVOID** contact with eyes and mouth, plastic and fabrics such as acetate, rayon and dynel. May damage furniture finishes, plastics and painted surfaces. **CONTENTS UNDER PRESSURE.** Do not place in hot water or near radiators, stoves or other sources of heat, or store at temperatures over 50°C. Do not contaminate food, utensils or

any body of water.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**DISPOSAL:** When container is empty, press button to release all pressure then dispose in household garbage. Do not puncture or incinerate.

**FIRST AID:** If in eyes: hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If accidentally swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
