## **DIRECTIONS FOR USE:**

Allegiance FL is a seed treatment formulation for use in commercial seed treatment operations for treatment of the listed crops. Allegiance FL may also be used for on-farm treatment of chickpea, lentil, peas, beans and soybean using conventional seed treating equipment which can accurately meter, mix and apply flowable seed treatment formulations. corn (field)	To aid in the control of seed rot caused by <i>Pythium</i> spp., apply Allegiance FL at a rate of $6.5 - 24.5$ mL per 100 kg seed. # APPLICATION RATE TABLE (mL per 100 kg seed)

The slurry should be applied as a spray into the mixing chamber of the seed treating equipment to ensure good coverage.

See instructions supplied with the applicable seed treater system for information on proper application techniques.

## SLURRY PREPARATION:

When preparing the slurry the following procedure should be used.

- 1. Partially fill the mixing tank with water.
- 2. Add the required quantity of Allegiance FL onto the water surface.
