PRECAUTIONS:

1. PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.
2. Harmful or fatal if swallowed.

ENVIRONMENTAL HAZARDS:

FIRST AID:

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-you-mouth, if possible. Call a Poison Control Centre or a doctor for further treatment advice.

IF IN EYES: Hold eye open and rinse slowly with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a Poison Control Centre or a doctor for further treatment advice.

Take container, label or product name and Pest Control Registration Number with you when seeking medical attention.

TOXICOLOGY INFORMATION: No specific antidote is available. Treat the patient symptomatically.

STORAGE:

Do not contaminate water, food or feed by storage and disposal. Store in a cool, dry, ventilated place that is secure.

DECONTAMINATION AND DISPOSAL:
