## **FIRST AID**

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**CONTACT WITH EYES:** Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**CONTACT WITH SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

**INHALATION:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth, if possible. Call a poison control centre or doctor for further treatment advice□□.

**INGESTION:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

## **PRECAUTIONS**

The following precautions should be observed in handling and using Nopcocide N-96 Manufacturing Concentrate.

**Do not get in eyes.** Nopcocide N-96 Manufacturing Concentrate is capable of causing severe eye damage. Wear goggles or eye shield when handling this product. See First Aid Procedures.

**Avoid contact with skin or clothing.** See First Aid Procedures.

**Do not take internally. Avoid breathing dust.**

**NOTE: Nopcocide N-96 Manufacturing Concentrate** may produce temporary allergic side effects characterized by redness of the eyes, mild bronchial irritation and redness or rash on exposed skin areas. Persons having allergic reaction should contact a physician.

### **PERSONAL PROTECTIVE EQUIPMENT**

Wear goggles or eye shield to protect eyes when handling Nopcocide N-96 Manufacturing Concentrate. Use protective barrier cream on exposed skin areas.

Wear gloves and protective clothing when handling or using Nopcocide N-96 Manufacturing Concentrate to minimize skin contact.

**Do not** inhale dust - wear a respirator if necessary. Launder outer garments if exposed to dust or spills. Discard footwear which cannot be decontaminated.

### **ENVIRONMENTAL HAZARDS**

**Nopcocide N-96 Manufacturing Concentrate** is toxic to fish. Keep out of lakes, streams or ponds.

### **STORAGE**

Store Nopcocide N-96 Manufacturing Concentrate in a dry place. Do not contaminate water, food or feed by storage or disposal.

### **DECONTAMINATION AND DISPOSAL**

For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean up of spills.

### **CONTAINER DISPOSAL:**
