PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. Potential skin sensitizer. Corrosive to eyes and skin. Do not get in eyes, on skin, or clothing. In case of contact, immediately flush eyes or skin with plenty of water. Get medical attention if irritation persists. May be fatal if inhaled. Do not inhale vapors or mist. When handling the concentrate, wear full-face protection with cartridge respirator and chemical resistant gloves, apron, cap and boots. Wear a long-sleeved shirt, long pants and chemical resistant gloves when handling this product. Use only in well ventilated areas. Do not wear contact lenses.

ENVIRONMENTAL HAZARDS:

This product is toxic to fish and wildlife. DO NOT discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or other waters in contravention of federal or provincial regulatory requirements. DISPOSAL:

1. Triple-or pressure rinse the empty container, add the rinsings to the treatment site.

2. Follow provincial instructions for any required additional cleaning of the container prior to disposal.
 3. Make the empty container unsuitable for further use.
 4. Dispose of the container in accordance with provincial requirements.
 5. For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean up of spills.

FIRST AID:

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

It is recommended that compatibility be checked in individual formulations. Amount of Mergal K10N Liquid Industrial Biocide based on total weight of product to treat:

Latex Emulsions 0.06 – 0.15 %

Aqueous Based Paints 0.06 – 0.5 %

Metal Working Fluids 0.05 – 0.5 %

For latex emulsions and aqueous based paints, Mergal K10N Liquid Industrial Biocide is to be used as an in-can preservative during storage and as a preservative during the manufacturing process.
