SHAKE WELL BEFORE USE

PRECAUTIONS: Harmful if swallowed. Avoid contact with skin, eyes, or clothing. KEEP OUT OF THE REACH OF CHILDREN. **Protective Clothing:** Wear long-sleeved shirt, long pants, coveralls, socks, shoes and chemical-resistant gloves. **Operator Use Precautions:** Wash hands before eating, drinking, using tobacco or using the toilet. After treating, wash thoroughly. If pesticide penetrates clothing, remove immediately, then wash contaminated skin thoroughly and shower. Launder contaminated clothing separately before re-use. **General Precautions:** Do not store near seed, fertilizer, insecticides or fungicides. Do not allow to freeze. Do not re-use empty containers. **Re-entry Interval:** Do not allow people (other than applicator) or pets on treatment area during application. Do not enter treated areas within 12-hours after application.

ENVIRONMENTAL HAZARDS: Toxic to small wild mammals, birds, aquatic organisms and non-target terrestrial plants. This product will harm other broadleaved plants in the vicinity of the treatment area. If applying this product using a handheld sprayer, do not directly spray or allow the spray to drift onto ornamentals or gardens. Do not spray exposed roots of trees and ornamentals.

LEACHING: The use of this chemical may result in contamination of groundwater, particularly in areas where soils are permeable (e.g. sandy soil) and/or the depth to the water table is shallow.

RUNOFF: To reduce runoff from treated areas into aquatic habitats, avoid application to areas with moderate to steep slope, compacted soil, or clay. Avoid application when heavy rain is forecast. Contamination of aquatic areas as a result of runoff may be reduced by including a vegetative strip between the treated area and the edge of the water body. To prevent runoff from domestic uses avoid spraying on driveways, sidewalks or other hard surfaces. Do not irrigate within 24 hours after application

DIRECTIONS FOR USE: The nozzle is closed when product is purchased. To open, depress the button on the top of the nozzle and adjust the nozzle to achieve the desired spray pattern. The more the nozzle is unscrewed the coarser the spray pattern. Coarse sprays are less likely to drift than fine sprays. Stand close to the weed. No need to bend down. Wet the weed with one or two short bursts. Do not use on Bent grasses or where Clover is desired.

WEEDS CONTROLLED: Dandelion, Plantain, Black Medick (yellow clover), Buttercup, Chickweed, Clover, English Daisy, Ground Ivy (Creeping Charlie), Knotweed (ironweed), Poison Ivy, Ragweed, Shepherd's Purse, Bedstraw, Heal-All, Devil's Paint Brush. **Note:** Excessive wetting of grasses around weed may cause some turf injury.

This product is designed to target treatment of weedy areas of lawns. This product is only effective when applied to the leaves of actively growing weeds. This product does not prevent weeds. Apply only when weeds are present.

DO NOT apply to any body of water. DO NOT contaminate irrigation/drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

Avoid application of this product when winds are gusty.

FIRST AID: **If in eyes**, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If on skin or clothing**, take off contaminated clothing. Rinse skin IMMEDIATELY with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. **If swallowed**, call a poison control centre or doctor IMMEDIATELY for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
