Application Rates

LIBERTY 150 SN Herbicide and Crop Desiccant MP for use on glufosinate-ammonium tolerant canola only

Add **DASH HC Adjuvant** to spray applications of LIBERTY 150 SN Herbicide and Crop Desiccant MP at 0.5% v/v (5 L **DASH HC Adjuvant** per 1000 L total spray solution) when tank mixed with Centurion® Emulsifiable Concentrate Post-Emergence Herbicide or Centurion Emulsifiable Concentrate Post-Emergence Herbicide and Facet® L.
