DIRECTIONS FOR USE: BUG-TEK is ready to use. Its special formula is nonstaining, and has no conspicuous odour. SHAKE WELL BEFORE USING.

For use indoors and outdoors around homes, greenhouses, campers, mobile homes, trucks, automobiles and in boats.

Within the specified use location, to enhance effectiveness of this product, apply this product directly to the listed pest where possible. Good sanitary practices should be maintained to prevent re-infestation.

Restrictions:

DO NOT apply to any body of water nor contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

Avoid application of this product when winds are gusty.

DO NOT contaminate food/feed nor apply to surfaces that may come into contact with food/feed.

DO NOT apply to people, pets, livestock or sources of electricity.

DO NOT apply to furniture (excluding bookcases and storage furniture), mattresses, linens, toys or clothing.

DO NOT apply to overhead areas or in confined spaces (e.g. attics, crawlspaces, small storage rooms, closets).

Ventilate treated areas after application by opening windows and doors, or using fans where required to aid in the circulation of air.

DO NOT apply when people, pets or livestock are present nor allow people, pets or livestock to enter treated areas until sprays have dried.

DO NOT allow spray to drip or allow drift onto non-target surface.

DO NOT apply in areas where plants are grown for food or feed (e.g., vegetables, fruit, herbs).

When treating the exterior surfaces of buildings, DO NOT treat soil, turf, or other plants adjacent to the building. DO NOT treat patios, porches, decks, gazebos or play structures.

DO NOT apply as a space spray or broadcast application.

How to Apply:

DO NOT APPLY AS A SPACE SPRAY OR BROADCAST APPLICATION.

Apply as a crack and crevice or spot treatment only. Spot treatment is localized to surface area not more than 0.2 m². Spots are not to be adjoining and the combined area of spots is not to exceed 10% of the total surface area of a room. Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.

Instructions for inside buildings:

To control cockroaches, sowbugs, ants, silverfish and spiders: Thoroughly treat inside building surfaces, including cracks, crevices in walls, floors and ceilings; along and behind baseboards; around water pipes and tanks; walls behind and floors beneath appliances (e.g., refrigerators and stoves) and furniture (e.g., shelves, drawers, cabinets and storage units); around sinks, drains and pipes; around garbage containers; around interior foundations; localized area around garbage cans; localized areas of floors and floor coverings and points

of entry (e.g., around windows and doors). For silverfish, also spray the cracks and crevices in bookcases. Remove all objects before treatment of bookcases where books, clothing, toys, towels and other items are stored. For ants, spray trails, nest and points of entry. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

To Control House Flies: Spot treatment only. Spray inside building surfaces around points of entry (e.g., screen frames, doors and window frames), around light fixtures and to localized areas of walls, floors and ceilings. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

To control fleas, and brown and American dog ticks: DO NOT apply to furniture, mattresses, linens, toys or clothing. Spray infested areas such as pet's bed and resting quarters, nearby cracks and crevices in walls and floors, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings. Spot treatments may be made with this product to pet bedding, or replaced with clean, fresh bedding after other listed areas are treated. Treatment must only be repeated after 7 days if pest problem persists or reoccurs. DO NOT SPRAY PETS WITH THIS PRODUCT. NOT FOR USE ON HUMANS.

INDOOR ORNAMENTAL PLANTS: Controls aphids, whiteflies, thrips, and leafhoppers on indoor ornamental plants. Safe to use on most ornamental plants. DO NOT apply to plants grown for food or feed. Spray upper and lower surfaces of plant leaves until damp but not to the point of run-off. Before treating delicate ornamental plants such as Coleus and African Violet, spray 1 or 2 leaves. If no effect is noticed after 2 days, it is safe to treat whole plant. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

Instructions for Outdoors on The Exterior Surfaces of Buildings:

To Control Ants, Fleas, House Flies, Spiders, Sowbugs and Brown and American Dog Ticks: For use outdoors on the exterior surfaces of buildings. Apply to the outside surfaces of foundations, under eaves troughs, around light fixtures, and places where listed pests enter (e.g., screens, doors, window frames). For house flies, apply as a spot treatment only. For ants, spray onto ant trails and points of entry. For spiders, apply to the exterior surfaces of buildings including under eaves, awnings and canopies. Treatment must only be repeated after 14 days if pest problem persists or reoccurs.

PRECAUTIONS: Wash thoroughly before eating, drinking and smoking. Remove fish bowls and aquariums from the treated area.

ENVIRONMENTAL PRECAUTIONS: Toxic to aquatic organisms, birds, bees and beneficial insects.

FIRST AID:

IF IN EYES

Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF ON SKIN/CLOTHING

Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

IF SWALLOWED

Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

STORAGE: Keep product in original container. Store in a cool, dry place. To prevent contamination store this product away from food or feed.

DISPOSAL: Do not re-use empty container. Triple rinse empty container and dispose in household garbage. Recycle wherever possible.
