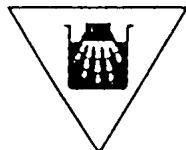

DIRECTIONS FOR USE:

INNER PACKAGE IS WATER SOLUBLE

Metal Working Fluids:

Dose at 0.6-1.2 kg per 10000 litres of system volume. Expel product directly into the sump at a convenient point.

Oilfield Applications:

Use 100 ppm active ingredient based on the water content of the system until control is achieved. Maintenance dosage 10-25 ppm. In all applications, expel the product into the system in the areas specified below:-

Gas Wells:

Introduce through wellhead valving system, so product drops down tubing.

Oil Wells:

Drop down tubing when sucker rods are pulled.

Storage Tanks:

Drop through thief hatch.

Recirculating Cooling Towers:

Pre-clean heavily fouled systems (e.g. with chlorine)

Shock dosages of 100 ppm based on the water content of the system may be used until control is achieved. Maintenance dosage 15-50 ppm. Expel the product directly into the sump of the system at a convenient point.

Each stick contains 100 grams of active ingredient.

FIRST AID:

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes.

Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.

Call a poison control centre or doctor for treatment advice.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If swallowed: Call a poison control or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

POTENTIAL SKIN SENSITIZER.
