Nuosept® 497 Preservative is an effective in-can preservative in the following aqueous compositions.

Application ranges or use concentrations based on the total weight of product are as follows:

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN.

CORROSIVE.

Causes severe eye and skin damage.

Do not get in eyes, on skin or on clothing.

Wear goggles or face shield when handling.

Wear a long-sleeved shirt, long pants and chemical-resistant gloves when handling this product. Remove and wash contaminated clothing before reuse.
