2. Remove and dispose of dry droppings daily. Replace litter when necessary.
3. Clean litter box weekly with a solution of hot water and ammonia.

PRECAUTIONS: Pregnant or nursing women and people with a suppressed immune system should note that a parasite found in cat feces can cause toxoplasmosis. They should exercise caution and consult a physician before handling a litter box. Always wash hands thoroughly after preparing or cleaning the litter box. Dispose of clumps or used and unused cat litter and packaging in accordance with local regulations.

Do not flush cat litter in toilets or dispose of it outdoors in gutters or storm drains, or any other waste water system. Keep the litter away from food preparation.

CONTENTS: Diatomaceous Earth, moisture activated scented agent.

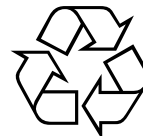
