DIRECTIONS FOR USE

Small unit: For equipment up to 60,000 BTU.

Large unit: For equipment over 60,000 BTU and up to 180,000 BTU.

Note: For larger equipment use multiple units.

1. Clean condensate pan and drain before installing unit.
2. Place unit in pan, pan side down.
3. In pans with drain connections, place unit under the cooling coil in the middle of pan length.
4. Unit must be in contact with condensate.

This unit is designed and approved only for use in drain pans of Air Conditioning systems and non-food Refrigeration Systems.

SUPPRESSES: Growth of slime forming bacteria which is the major cause of drain blockages.

STORAGE AND DISPOSAL
