GENERAL INFORMATION:

DEER GUARD® is a ready to use deer repellent that discourages deer (*Odocoileus* spp.) from feeding on trees, shrubs, ornamentals, conifers, and non-bearing deciduous trees. DEER GUARD® is ready to use and required no mixing. Use this product only at ambient temperatures between 5°C and 32°C (40°F and 90°F). Do not use on food or feed crops. Although DEER GUARD® has been tested on many species of plants and trees and is not believed to be phytotoxic, it is advisable to treat small portions of plants that may be especially sensitive before treating entire plant. Children and pets may enter treated area after spray has dried. Do not apply or drift onto stone, concrete or siding as staining may occur. **Keep from freezing**

DIRECTIONS FOR USE: Shake well before using. Transfer to any pump sprayer equipped with a cone or flat fan nozzle. Adjust nozzle to obtain even coverage. Apply only to dry plants. Hold spray tip 30 to 60 cm (1 to 2 ft) from plants and spray leaves, needles, buds and branches subject to browsing by deer. Thoroughly wet surfaces but do not apply to the point of significant run-off. For best results, apply to bare branches in fall and to unprotected foliage in spring. Repeat treatment as deer damage resumes. Avoid drift.
